

Statutory Declaration

Section 31(6), Highways Act 1980

I, Michael A Weston for and on behalf of Woodhouse Properties Inc, DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. I am and have been since 13<sup>th</sup> September 2000 the owner within the meaning of the above section of the land known as The Great Durnford Estate more particularly delineated on the plan accompanying this statement and thereon shaded beige.
2. On the 30<sup>th</sup> day of November 2004 I deposited with Wiltshire County Council, being the appropriate Council, a statement accompanied by a map delineating my property by beige shading which stated that the ways coloured red on the said map and on the map accompanying this declaration had been dedicated as highways with vehicular status, the ways coloured green on the said map and on the map accompanying this declaration had been dedicated as bridledways, that the ways coloured dashed magenta on the said map and on the map accompanying this declaration had been dedicated as footpaths, no other ways had been dedicated as highways over my property.
3. No additional ways have been dedicated over the land shaded beige on the plan accompanying this declaration since the Statement dated 30<sup>th</sup> November 2004 referred to in 2. above.

AND I MAKE this solemn declaration on the 24 day of January 2005 conscientiously believing it to be true and by virtue of the Statutory Declarations Act 1835.

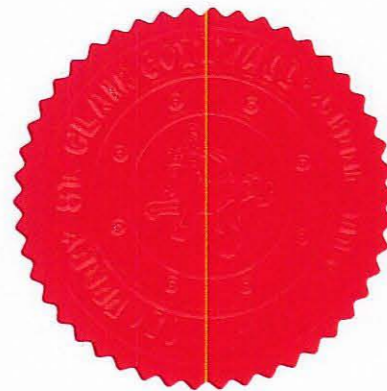

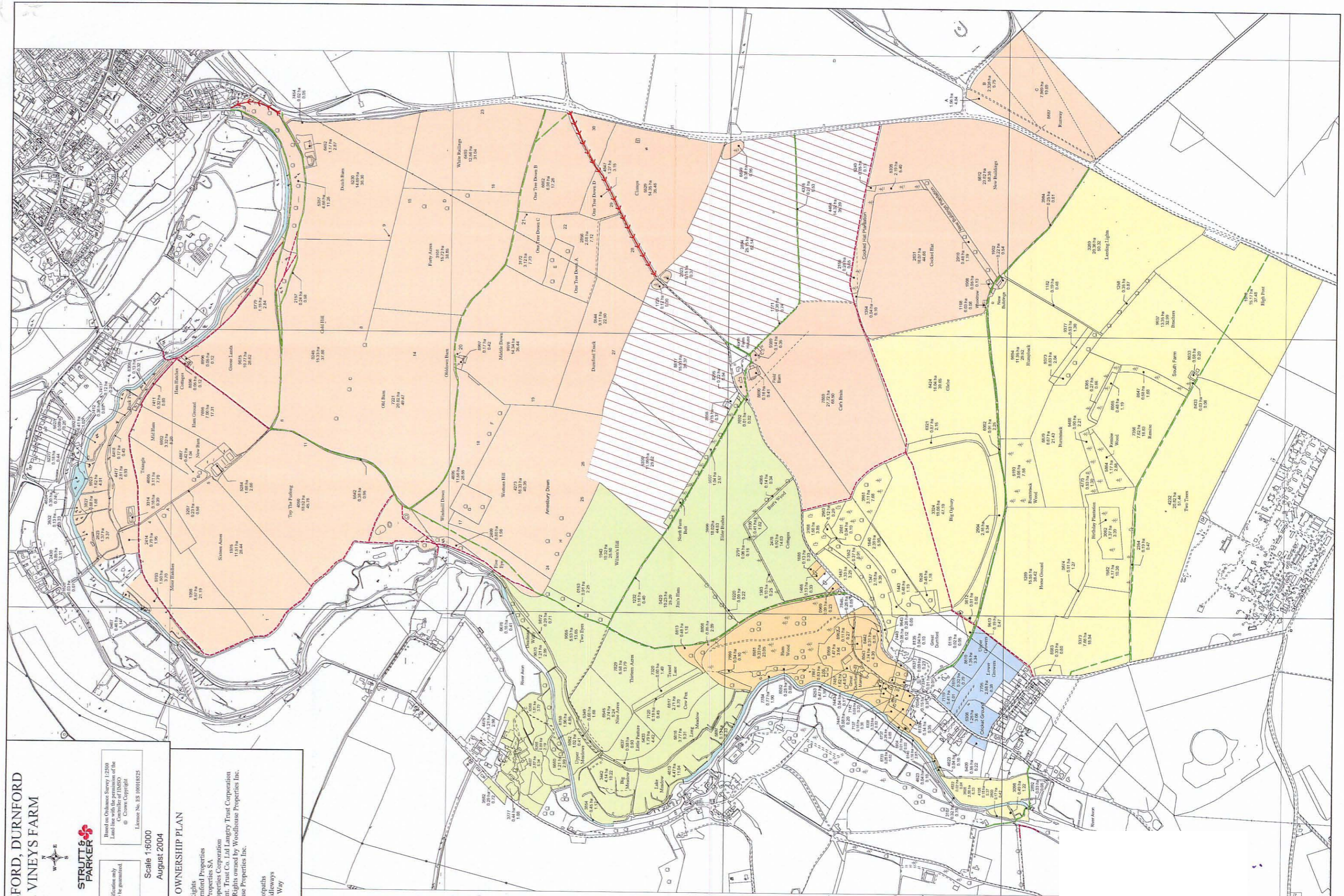
